SUBJECT: **FINAL SHARING RATIOS FOR FISCAL YEAR (FY) 2023-24 FOR THE CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS (CALWORKS) – CA 800 FEDERAL ASSISTANCE EXPENDITURES**

This letter informs counties of the final federal, state/county 2011, and county sharing ratios for the federally eligible CalWORKs Assistance expenditures for FY 2023-24 to meet Single Audit Reporting requirements.

For payment and advancing purposes during FY 2023-24, the sharing ratios were kept at 97.5/2.5 percent (federal/state/county 2011 and county). The state share includes the funds deposited in the county CalWORKs Maintenance of Effort subaccount and Family Support subaccount administered by the State Controller's Office. After the final reconciliation of all CalWORKs payments, the final sharing ratio is 36.3 percent federal, 61.2 percent state/county 2011 and 2.5 percent county.

To determine the amount of federal and state/county 2011 funds for the CalWORKs assistance program for FY 2023-24, please refer to the example below.

If the county's total FY 2023-24 CalWORKs assistance expenditures claimed on the CA 800 federal claim was \$1 million, the breakdown of the funding is as follows:
