PIN 19-17-ASC announces changes in the Adult and Senior Care Program.

The California Department of Social Services (CDSS), Adult & Senior Care Program (ASCP), Community Care Licensing Division (CCLD) is pleased to announce the reorganization of the Sacramento Adult & Senior Care Regional Offices, redirect of the Chico Adult & Care Unit, and transfer of the Continuing Care Contracts Bureau. The purpose of this reorganization is to optimize administration services through a more even workload distribution and align similar CCLD programs to avoid duplication of efforts and improve resident safety.

Sacramento North and South Adult & Senior Care Regional Offices

The Sacramento Adult & Senior Care Regional Office has been divided into the Sacramento North Adult & Senior Care Regional Office, managed by Regional Manager Alycia Berryman, and the Sacramento South Adult & Senior Care Regional Office, managed by Regional Manager Krystall Moore. Both offices will share the same office location and contact information but will provide services for different counties within the region. The existing caseload has been split between the two offices.

The Chico Adult & Senior Care Unit was previously managed by the Rohnert Park Regional Office and has been redirected to the new Sacramento North Adult & Senior Care Regional Office. The purpose of this reorganization is to provide additional oversight and support to this satellite unit by redirecting it to a regional office closer in proximity.
