REVISED ADDENDUM TO SECTION (m) ASSISTING FAMILIES TRANSITIONING OFF AID Los Angeles County CalWORKs Plan November 2008

Please describe how the county will work with families transitioning off aid. The description should include assistance for those individuals who transition off aid due to time limits. [Reference: WIC Section 10531 (m)].

Los Angeles County offers post-time limit (PTL) services to individuals who have exhausted their 60 months of cash aid. PTL eligibility:

- •e Begins on the date the adult participant is removed from the Assistance Unite (AU), due to time limits, ande
- •e Ends 12 months from the date the adult participant was removed from the AU.e

PTL participation is **voluntary** and contingent upon the participant's agreement to participate in a Job Intern (JI) community service assignment for up to 32 hours per month or the number of hours permitted under the Simplified Food Stamp Program minimum wage calculation, whichever is less. Exception: There is no JI participation requirement for employed participants.

Factors to consider when determining a reduction of hours or a waiver of a JI assignment, when applying the 32 hours per month service requirement include, but are not limited to the following:

- •e Good Cause,e
- •e Lack of necessary supportive services,e
- •e Travel time to the community service assignment,e
- •e Distance to the child care provider,e
- •e The availability of suitable special needs child care for children with identifiede special needs,e
- •e Distance to the nearest transportation system, ande
- •e The JI assignment must not interfere with current employment or WtW activities.e

PTL services include, but are not limited to:

- •e Supportive Services payments (Transportation, and Education/Training ande Ancillary Expenses)e
- •e Specialized Supportive Services Assistance (Domestic Violence, Substancee Abuse, Mental Health and Learning Disabilities)e
- •e Homelessness Preventione
- •e Life Skills Traininge
- •e Job Intern Activities (Community Services)e

- •o Work Experienceo
- Vocational and Career Assessmento
- Vocational Activitieso
- Self-Initiated Program Activitieso
- Vocational Training Program Activitieso
- Job Skills Training, designed for upward career mobilityo
- Transitional Subsidized Employmento
- O Child Care (Subsidized child care assistance is available to timed-off participantso who work or participate in welfare-to-work activities for up to 24 months aftero CalWORKs discontinuance.)o
- •• Earned Income Tax Credit (EITC) Counselingo
- •• Job Retention Serviceso
 - Supportive Services payments (Work-Related Transportation and Ancillaryo Expenses)o
 - > Job Skills Training designed for upward career mobilityo

PTL SERVICES ELIGIBILITY

PTL education/training, and related supportive services are available for timed-off participants for up to 12 months after timing-off CalWORKs.

JOB RETENTION ELIGIBILITY

Job retention services are available for timed-off participants for up to 12 months after timing-off CalWORKs. Eligible participants must be employed either:

- •o Full-time working a minimum of 32/35 hours per week (single/two-parento household) and earning at least the state minimum wage; oro
- •• Part-time and concurrently engaged in Welfare-to-Work (WtW) activities in anyo combination of work and WtW activity hours for a minimum total of:o
 - > 20 hours per week (one-parent with a child under age 6); oro
 - > 32 hours per week (regardless of household composition).o
- •• If working less than 20/32 hours per week, the GSW will offer the adulto participant an opportunity to participate in concurrent WtW activities that willo bring their total weekly participation up to the 20/32 hour minimum.o
