1. Zouc Yietc Nzunc Jaaubv (Lump Sum Payment) – Meih haih longc nyaanh sotv caux/fai benc piux leic dauh jaaubv sung nzengc fai jaaubv deix dongh meih qiex nyei soux mouc.
2. Jamv Leic Dauh Zoqc Njiec (Benefit Reduction) – Se gornge meih ih zanc duqv jienv benc piux leic dauh nor, meih haih jamv biauv zong nyei leic dauh zoqc njiec weic jaaubv nzuonx yietc zungv fai jaaubv deix dongh mieh qiex nyei soux mouc. 4. Paaiv Daaih Oix Zuqc Jaaubv Nzuonx (Ordered Repayment)
