## (a) COLLABORATION WITH PUBLIC AND PRIVATE AGENCIES TO PROVIDE TRAINING AND SUPPORTIVE SERVICES

- 1. The name(s) of the WtW Grant operating entities working with each county.
  - Sacramento Employment and Training Agency (SETA), (**Attachment I**).
  - Volunteers of America, Inc.
- 2. A description of the collaboration and coordination between counties and operating entities to ensure services are not duplicated. This includes but is not limited to:

- Relationships established between the local Child Support Services (IV-D) agencies to identify and serve non-custodial parents, if applicable. Not applicable.
  - Our original plan coordination referenced several of these activities. We are entering the fourth year of Welfare-To-Work services. As part of our welfare reform implementation plan, we jointly agreed that SETA would focus on long-term welfare recipients (30 months or more on aid). We helped identify clients meeting the 30-month criteria and helped SETA target those families for service. As a result, SETA has been very successful in enrolling over 1,105 "hard to employ" CalWORKs recipients in Welfare-to-Work activities including On-the-Job Training (OJT) and Work Experience (WEX) program. The One-Stop Centers provide enhanced employment services; currently SETA operates 14 One-Stop Centers in Sacramento County.
  - SETA staff conducted workshops for DHA staff outlining the requirements and the referral process for WtW participants. SETA staff also developed a workbook to use by DHA staff as an easy reference for referring participants.
  - Recognizing that a variety of housing issues face youth leaving the foster care system; our department agreed that Volunteers of America, Inc. will administer the Laverne Adolfo Housing Programs for Emancipated Foster Youth, that will provide safe and stable housing to youth up to the age of 24 who have left the foster care system.
- 3. A description of each county's coordination of the expenditure of the State WtW Grant matching dollars with WtW Grant formula funds. For example:
- If applicable, an explanation of how the county is passing the State match through to the Local Workforce Investment Boards or other providers and what services are being provided with the matching funds by these organizations.
- A description of what services and activities are being provided with the state match dollars and who is providing the services, if they are not provided by the county to ensure services are not being duplicated.

- The Department of Human Assistance will pass through \$595,923 of our FY 01/02 allocation of the WtW State Grant Matching Funds to SETA to increase the number of clients to be served in the long-term welfare recipient's category. Our agreement is that they will provide wage subsidies for CalWORKs recipients to participate in OJT and WEX activities.
- Our department will fund and administer \$165,983 WtW matching funds for use by DHA's Community Services Program to provide wage subsidies for CalWORKs recipients to participate in On-the-Job-Training or Work Experience activities.
- DHA will fund and administer \$62,000 WtW matching funds for a Program Planner staff position for the Homeless Foster Youth program. The Program Planner will develop and coordinate the Foster Youth Housing Programs and a Foster Youth Continuum of Care, coordinate and participate in a foster youth community advisory committee; enhance funding sources for the foster youth collaborative and oversee budgeting and contract activities. In addition, the Program Planner will develop an evaluation process of the program.
- Our department will pass through the remainder of the WtW matching funds to Volunteers of America, Inc. The program will provide 24-hour on-site supervision in two Sacramento locations for youth that have left the foster care system. Participants will be actively involved in either employment or seeking employment, and education. Both sites are close to community college campuses. The program will enable youth to acquire skills and hands-on, practical day-to-day living experiences. Special emphasis will be placed on providing the knowledge, attitudes and behavioral skills necessary to make responsible decisions regarding homelessness, pregnancy prevention and reproductive health. The housing program is designed to prepare youth to become positive, self-sufficient citizens in their community. Support and guidance to participants will be provided by a collaborative of community agencies consisting of Department of Human Assistance, Department of Health and Human Service, Sacramento Employment and Training Agency and the Casey Family Program.
- 4. A narration describing the methods counties and operating entities are using to identify, refer and serve eligible WtW Grant populations.
  - We allowed the providers to have more autonomy to enroll participants in order to
    expedite services to participants. In collaboration between DHA and SETA staff, a
    program document and a Self-Appraisal form (SC246.105) were developed for use in
    determining eligibility and referring CalWORKs recipients to the WtW Program. SETA
    staff has developed a Certification Unit to review the Self-Appraisal form to determine
    who will likely be eligible for the program.
  - The former Foster Youth are easily identifiable from our Foster Care case records.
