The purpose of this All County Information Notice (ACIN) is to provide counties with the California Child and Family Services Report (C-CFSR) statewide five-year schedule for 2015 - 2019. This ACIN supersedes ACIN I-16-12.

**BACKGROUND**

Assembly Bill 636 (Steinberg), Chapter 678, Statutes of 2001, enacted the Child Welfare Services Outcomes and Accountability Act of 2001. This law required the California Department of Social Services (CDSS) to establish the C-CFSR process. The C-CFSR commenced in January 2004 with implementation instructions provided to local child welfare and probation agencies through issuance of ACL-04-05.

The purpose of the C-CFSR is to significantly strengthen the accountability system used in California to monitor and assess the quality of services provided on behalf of youth in the foster care system. As such, the C-CFSR operates on a philosophy of continuous quality improvement, interagency partnerships, community involvement and public reporting of program outcomes. The C-CFSR is comprised of county child welfare system reviews and maximizes compliance with federal regulations for the receipt of federal Title IV-E and Title IV-B funds. Principal components of the C-CFSR Process include: 1) County Self-Assessment (CSA), 2) County System Improvement Plan (SIP), and 3) County System Improvement Plan Progress Reports (SIP Progress Reports).

The C-CFSR five-year schedule is based on a calendar year. The first page of the attached calendar is an overview of CSA due dates for all counties across the five-year cycle. The remaining pages of the calendar provide the continuing C-CFSR schedule identified in ACIN I-16-12.

It is important to note two major components of the next federal CFSR in which CDSS will be working with county child welfare and probation agencies on. The first is the Child Welfare Services (CWS) Case Record Reviews which will be used to inform the C-CFSR process in the development of the CSA and SIP. The purpose of the CWS Case Record Reviews is to assess child welfare and probation practice, including the application of federal and state policies and procedures, and the use of evidence-based practices to gain an understanding of the relationship between these and the success and/or barriers to improving outcome measures and systemic factors. A forthcoming ACL will address the CWS Case Record Review process in more detail. Second, the Administration of Children and Families (ACF) recently released the final notice of the statewide data indicators and national standards for CFSRs. Changes to the CFSR measures include new indicators as well as new methodology for calculating the measures. Additional information on the new CFSR measures will be forthcoming. In the meantime, please see the final notice from ACF at the link below.
