SUBJECT: REVISION TO THE WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA): MANDATORY PARTNERSHIP REQUIREMENTS FOR CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS (CalWORKs) WITH AMERICAN JOB CENTERS OF CALIFORNIA (AJCCS)

The purpose of this All County Letter (ACL) errata is to revise the due dates for two requirements under the WIOA following the publication of the final regulations from the Departments of Labor and Education on August 19, 2016. The revisions change the due date for the local workforce development boards (local boards) to have career service providers in place and the due date to complete Phase II of the memorandum of understanding (MOU) with the county welfare departments.

The following are the revisions for the due dates provided in the “Timeline” on page two of [ACL No. 16-51](#):

- ~~June 30, 2017~~ **July 1, 2017**: Local Boards ensure that AJCC operators and career services providers are in place (including access to CalWORKs services).
- ~~December 31, 2017~~ **June 30, 2017**: Local Boards complete Phase II of the MOUs (Resource Sharing).

Additionally, the due date for Phase II of the MOU on page five of [ACL No. 16-51](#) under “Role and Responsibility #3” is revised to match the due date in the “Timeline”:

- **Phase II, Shared Resources and Costs**: Local Boards will build upon the agreements established in Phase I through the sharing of resources and costs. Phase II of each MOU must be completed no later than ~~December 31, 2017~~ **June 30, 2017**.
