The section entitled “County Clothing Allowances and the Supplemental Clothing Allowance Line” should be disregarded. Counties should continue to claim county clothing allowances as explained in [CFL No. 01/02-01](#) and [CFL No. 07/08-25](#). All county clothing allowances should be included in the main payroll (or other lines in the current or prior month payroll, if applicable). This amount shall be included in calculation of the Reconciliation base.
