SUBJECT: CROSS-COUNTY EMBOSSING OF ELECTRONIC BENEFIT

TRANSFER (EBT) CARDS

The purpose of this notice is to provide information regarding a county's ability to emboss an EBT card in another county. Counties will perform cross-county embossing when the client is owed benefits and the client resides in a new county and no longer has possession of their former EBT card. A client may be owed benefits due to an available balance on their account or due to a hearing award.

When a county owes EBT benefits to a former resident, the county may apply those benefits to the recipient's account number in the former county and print an EBT card in the new county of residence using cross-county embossing. Attached is EBT Information Update No. 01216 that was communicated to the counties and the Statewide Automated Welfare System consortia on January 10, 2005, when the EBT system was maintained by JP Morgan EFS. The same process is applicable under the new EBT vendor contract with Affiliated Computer Services (ACS). The Cross-County Embossing matrix is available on the EBT WorkSite Web. Using a log-in name and password, each county and consortium can access the EBT WorkSite Web.

The Cross-County Embossing matrix contains the information necessary for each county to perform cross-county embossing. The matrix contains the county contact information, the local county address, type of embosser, and the embosser identification number for each embossing device. Prior to initiating cross-county embossing, it is essential to contact the identified county employee at the target county. Most counties have established embossing procedures that must be followed.

EBT Operations works with the EBT vendor, ACS, to maintain the Cross-County Embossing matrix. In the event a county finds it necessary to update the information contained in the matrix, please communicate directly with the EBT Project Office, Operations Unit at ebtoperations@osi.ca.gov. EBT Operations sends communications to numerous county and consortia staff whenever an updated matrix is available on the EBT WorkSite Web.
