The purpose of this notice is to inform county welfare and probation departments of a statewide training for the Title IV-E Foster Care PIP. The Foster Care training in Stockton on June 10, 2010, from 1:00 p.m. to 4:00 p.m., Redding on June 28, 2010, from 9:00 a.m. to 12:00p.m., and Orange on July 21, 2010, from 1:00 p.m. to 4:00 p.m., is sponsored by the California Department of Social Services (CDSS). The training will focus on error cases identified in the 2009 Title IV-E Review, cases in which the Administration for Children and Families (ACF) found the state in non-compliance during the review period.

Due to the limited seating capacity at the training locations, the CDSS recommends each county send appropriate staff; a representative from social work services, a Foster Care Eligibility Supervisor, and a Probation Officer.

Topics of Training

Some of the topics to be discussed at the training include:

- Aid to Families with Dependent Children Eligibility
- Reasonable Efforts to Finalize Permanency
- Licensing/Approval of Foster Family Homes and Childcare Institutions
- Provider Safety Requirements
- Best Practices
