SUBJECT: CHAFEE EDUCATION TRAINING VOUCHER (ETV) PROGRAM  
ELIGIBILITY VERIFICATION PROCESS

REFERENCE: ALL COUNTY LETTER (ACL) 07-33

The purpose of this All County Information Notice (ACIN) is to provide guidance on the current Chafee ETV eligibility verification process. This ACIN supersedes ACL 07-33. Attachments include the revised eligibility verification process, the revised Chafee ETV Foster Care Eligibility Certification form, a current Chafee ETV contact list, and a current Independent Living Program Coordinator list.

It is our intent that eligible foster youth seeking higher education receive assistance in an expeditious manner. The verification process is critical to timely receipt of ETV grants. Most new grant applications are submitted for fall attendance in an education or training program. Thus counties should ensure that eligibility verification is done in a timely manner so that grants are awarded in sufficient time for youths to enroll and attend their programs.

The Chafee ETV Program provides grants up to \$5,000 per year to current and former foster youth to use for higher education or technical training. Youth may use the grant to pay for education related expenses, including child care, transportation and rent while they're in school. Applicants must have been court dependents or wards and placed in foster care for one day or more between the ages of 16 and 19 and have a financial need. First time applicants must be under 22<sup>nd</sup> years of age as of July 1<sup>st</sup>, of the award year. If a youth receives a grant, it may be renewed through their 23<sup>rd</sup> birthday to allow the youth to complete the school year.

In this updated foster care eligibility verification process, the California Student Aid Commission (CSAC) confirms the Chafee ETV applicant's foster care history and dependency or wardship status during placement using an encrypted data file provided by the Department of Social Services (CDSS).

If CDSS data file does not confirm placement history or dependency/wardship status during placement, the applicant must enter basic identification information on the Chafee ETV Foster Care Eligibility Certification form (previously called the ILP Eligibility Certification form) and forward it to the appropriate Chafee ETV contact. The Chafee ETV contact verifies the applicant's foster care history and status during placement and forwards the form to CSAC, who enters the updated information into the applicant's file.

The updated verification process was developed by a workgroup convened by CDSS as a collaborative effort with CSAC, key county staff, the Community College Chancellor's Office and college financial aid staff. Chafee Education and Training Voucher (ETV)  
Revised Foster Care History Confirmation Process

Eligible applicants must have been court dependents or wards and in foster care for one day or more between their 16<sup>th</sup> and 19<sup>th</sup> birthdays, and have financial need. Initial applicants must be under 22 years of age as of July 1 of the award year.

**Foster Care History Confirmation Process**

- Applicants complete and submit the Chafee ETV Grant Application to the California Student Aid Commission (CSAC). That application can be completed [on line](#), [downloaded](#), requested from the Student Aid Commission at (888) 224-7268, or obtained from the applicant's financial aid office.

Applicants must also complete the Free Application for Federal Student Aid, which can be completed online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) or requested from the applicant's financial aid office.

- When a Chafee ETV application is received, the CSAC determines if the applicant is listed in an encrypted data file of current and former foster youth electronically submitted by the California Department Social Services.
  - If the data file confirms the applicant's foster care placement history and court dependency /wardship status during placement, the CSAC continues to process the application.
  - If the applicant is not in the data file, the county where the applicant is now living must examine CWS/CMS records, case file documents, and court records to confirm the applicant's foster care placement history and court dependency/wardship status.
    - These applicants must complete the first section of the California Chafee ETV Program Foster Care Eligibility Certification Form and forward it to the designated Chafee ETV contact.

**Applicants must complete the Foster Care Eligibility Certification Form ONLY if the CDSS data file does not show qualifying foster care history.**

- The Chafee ETV contact will verify the applicant's foster care placement history and court dependency/wardship status during placement and send the completed Eligibility Certification form to the CSAC.
- After the application is complete, the CSAC will place the applicant on a priority list based on criteria posted on the Chafee Home Page. Applicant prioritization is

necessary due to the lack of sufficient Chafee ETV funds to serve all eligible applicants.

- The CSAC determines the amount of the applicant's financial aid eligibility based upon a Needs Analysis Report prepared by the college or vocational school financial aid office.
- Following the grant award decision, the CSAC sends the applicant a notification letter informing them of their grant award and amount. In addition, applicants can check their award application status on the Chafee Web Grants website at <https://mygrantinfo.csac.ca.gov>.
- The CSAC sends the Chafee ETV voucher to the applicant's financial aid office.

### **California Student Aid Commission Roles and Responsibilities**

- The CSAC will respond to telephone calls, email inquiries, and correspondence requesting general Chafee ETV program information. The CSAC will also respond to requests for application-specific assistance from applicants and financial aid offices.
- Following receipt of complete Eligibility Certification Forms, the CSAC will update the student's CSAC record. Reconfirmation will not be necessary as long as the student meets Chafee ETV program participation requirements.
- When requested by the CDSS, the CSAC will submit a list of Chafee ETV grant awardees for the current academic year. This list will be the basis for process and outcome audits by the CDSS.

### **Chafee ETV Contact Roles and Responsibilities**

- The Chafee ETV contact will complete the Foster Care Eligibility Certification Form and forward to the CSAC.
- For Chafee ETV applicants whose qualifying foster care history was in another state, the Chafee ETV contact in the county of current residence will obtain appropriate documentation from the other state and complete the Foster Care Eligibility Certification Form.
- For applicants residing in other states whose qualifying foster care was in California, the point of contact for the county where the applicant was in foster care will provide documentation of that history to the state of residence.

## California Department of Social Services – Roles and Responsibilities

- The CDSS will provide technical assistance to counties and to the CSAC regarding documentation of foster care history and court status during placement, including CWS/CMS entries, minute orders, case file documents, and related case file and legal documents.
- The CDSS will provide information on the Chafee ETV program to potential applicants and will provide county and CSAC contact information whenever appropriate.
- The CDSS will respond to telephone calls, email inquiries, and correspondence requesting general Chafee ETV program information.
- The CDSS will refer requests for application-specific assistance to the CSAC.
- In response to inquiries from Chafee ETV applicants whose qualifying foster care history was in another state, the CDSS will refer the applicant to the point of contact designated for the county where the applicant is now residing
- In response to inquiries from Chafee ETV applicants residing in other states whose qualifying foster care history was in California, the CDSS will refer the applicant to the point of contact for the county in which the applicant was in foster care
- At least twice annually, the CDSS will update the Chafee ETV contact list.
- At least quarterly, the CDSS will submit written requests to the Administration for Youth and Families for Chafee ETV funds not expended by other states.

**California Chafee Education and Training Voucher Program  
Foster Care Eligibility Certification Form**

The California Chafee Education and Training Voucher Program awards grants to eligible youth to attend postsecondary education or training programs. Anyone under 22 who was a dependent or ward of the court and in foster care for one day or more between the ages of 16 and 19 can apply. On this form applicants and designated county staff provide information to the California Student Aid Commission to verify the applicant's foster care placement history.
