SUBJECT: COUNTY CHILDREN'S TRUST FUND SHARE OF KIDS' PLATE REVENUE

This notice is to inform you that CDSS will distribute the Kids' Plate revenue allocated by the State Fiscal Year (SFY) 2012-2013 Budget Act. The total distribution for SFY 2012-13 is \$896,000. Each county's share is based on their proportion of the state's population of children ages zero to 18 as reported by Department of Finance statistics starting July 2011. The allocations for the fiscal year are shown on the enclosed chart (Attachment A).

The California Department of Motor Vehicles generates the Kids' Plate revenue from initial and renewal fees for custom and sequential California "Kids" vehicle license plates. The intent of the revenue is to strengthen health and safety protections for children and to help fund programs to reduce child injury and child abuse. Pursuant to California Vehicle Code Section 5072, Kids' Plate revenue is deposited into the Child Health and Safety Fund. Welfare and Institutions Code Section 18285(e) (1) provides up to 25 percent of the monies to fund child abuse prevention programs (22.5 percent to the County Children's Trust Fund and 2.5 percent to the State Children's Trust Fund). The remaining monies are to be used for licensing activities related to the Child Care program of the Community Care Licensing Division within the California Department of Social Services, and for childhood injury prevention programs and activities.

To facilitate your efforts toward preventing child abuse and neglect and in early intervention, we encourage you to coordinate the use of the Kids' Plate revenue with other funding sources such as Child Abuse Prevention, Intervention and Treatment, Community-Based Child Abuse Prevention, and Promoting Safe and Stable Families funds.
