This letter informs counties that the United States Department of Agriculture, Food and Nutrition Service (FNS) has issued the Federal Fiscal Year (FFY) 2017 Disaster Supplemental Nutrition Assistance Program (D-SNAP) Income Eligibility Standards and Allotments for the period of October 1, 2016 through September 30, 2017.

The computation below shows how FNS computes the Disaster Gross Income limits for a one person household:

Maximum Monthly Net Income Limit for household size of one (100% of FPL)	+ \$990
Maximum Standard Income Deduction	+ \$157
Maximum Shelter Expense Deduction	+ \$517
Disaster Gross Income Limit	= \$1664
