INFORMATION ON CALFRESH COST-OF-LIVING ADJUSTMENTS SUBJECT:

(COLAs) - EFFECTIVE OCTOBER 1, 2016.

REFERENCE: UNITED STATES DEPARTMENT OF AGRICULTURE (USDA), FOOD

AND NUTRITION SERVICE (FNS) APPROVAL OF CALIFORNIA'S STANDARD UTILITY ALLOWANCE, LIMITED UTILITY ALLOWANCE, AND TELEPHONE UTILITY ALLOWANCE DATED AUGUST 12, 2016, AND ALLOWANCE INCREASE EFFECTIVE OCTOBER 1, 2016.

This letter transmits information on the COLAs for Federal Fiscal Year (FFY) 2017, which apply for the period October 1, 2016 through September 30, 2017. The CalFresh COLAs provided in this letter are effective October 1, 2016 for all households.

#### Maximum Allotments

Allotments may be adjusted by FNS annually on October 1 to account for changes in the cost of the Thrifty Food Plan (TFP). The unchanged maximum allotments for all households are listed in the table below:

#### Maximum Shelter Deduction

The maximum shelter deduction for households without elderly or disabled members for FFY 2017 increased from \$504 to \$517. (ATTACHMENT I)

#### Homeless Household Shelter Allowance

The homeless household shelter allowance will remain the same as FFY 2016 at \$143. (ATTACHMENT I)

#### **Standard Deduction**

The standard deductions for households and maximum shelter deductions have changed as the chart shows below. The minimum standard deduction for households with 1 to 3 persons changed from \$155 to \$157 a month. (ATTACHMENT I)

#### Standard Deductions for FFY 2017:

#### Standard Utility Allowance (SUA)

Effective October 1, 2016, the SUA amount increased from \$385 to \$389 for FFY 2017. A household that has heating and cooling costs separate from their rent or mortgage is eligible for the SUA.

#### Limited Utility Allowance (LUA)

Effective October 1, 2016, the LUA amount increased from \$118 to \$122 for FFY 2017. A household that does not qualify for the SUA, but incurs expenses for at least two separate utilities other than heating and cooling, is eligible for the LUA.

#### <u>Telephone Utility Allowance (TUA)</u>

The TUA amount will remain unchanged at \$19 for FFY 2017. A household that is not eligible for the SUA or LUA, but incurs a telephone expense, or an expense for an equivalent form of communication is eligible to receive a TUA.

#### Income Eligibility Standards

Income Eligibility standards are listed in ATTACHMENT I, which include charts of the "Net and Gross Monthly Income Eligibility Standards," "Gross Monthly Income Eligibility Standards for Households Where Elderly/Disabled Are a Separate Household" and "Gross Monthly Income Eligibility Standards for Modified Categorical Eligibility (MCE) / Broad-Based Categorical Eligibility (BBCE)."

#### Stuffer Notice

The CF 11 (ENG/SP), the general mass change notice, is included in this package. This notice informs clients about changes in CalFresh allotments and the SUA/LUA deduction amount. There is no change in the TUA deduction. Prior to duplication, County Welfare

Departments (CWDs) must ensure that the CF 11 notice contains the county-specific address that clients should use to send written state hearing requests.

In accordance with the Manual of Policy and Procedures (MPP) section 63-504.39, CWDs must inform all households on or before October 1, 2016 of the new CalFresh benefit amounts and deductions. CWDs may opt to use the mass change notice or may notify households via the news media or may post this information in certification offices, issuance locations or other sites frequented by certified households. However, households must be informed of the changes no later than October 1, 2016.

The CWDs shall ensure that effective bilingual services are provided. This requirement may be met through utilization of paid interpreters, qualified bilingual employees, and qualified employees of other agencies or community resources. These services shall be provided free of charge to the applicant/recipient. In the event that the California Department of Social Services (CDSS) does not provide translations of a form, it is the county's responsibility to provide the translation if an applicant or recipient requests it. ## NOTICE TO ALL CALFRESH RECIPIENTS IMPORTANT — PLEASE READ

Effective October 1, 2016, State and Federal laws provide for the following:

<u>Maximum CalFresh Allotments:</u> These are benefit amounts your household would receive if your household had no income.

- Additionally, the maximum excess shelter deduction has increased from \$504.00 to \$517.00.
- The homeless shelter allowance of \$143.00 remains unchanged.
- The standard deductions have changed as follows:

#### Standard Deductions for FFY 2017:

Household Size	Standard Deductions
1 to 3 persons	\$157.00
4 persons	\$168.00
5 persons	\$197.00
6 or more persons	\$226.00

The Standard Utility Allowance (SUA) of \$385.00 increased to \$389.00.

The Limited Utility Allowance (LUA) of \$118.00 slightly increased to \$122.00.

If the SUA/LUA is used as part of your shelter deduction and if you have had no changes in your CalFresh case, your CalFresh benefits may be changed. With the changes in your CalFresh benefits, the amount you will get depends on other household changes. These changes will be included in any notice you get that tells you about other changes in your CalFresh benefits.

If you think we made a mistake in figuring your October CalFresh benefits due to the new amounts for allotments and SUA/LUA you may ask for a state hearing, *within 90 days of when you got this letter* by writing to:

or you may call toll free: 1-800-952-5253. If you are deaf and use TDD, call 1-800-952-8349. When you ask for a state hearing, you must tell us why you think we made a mistake. You can speak for yourself at the hearing or you can have a friend, attorney, or other person speak for you, but you must get these people to help you. You may ask for free legal aid at a legal aid office in your area.

### AVISO A TODAS LAS PERSONAS QUE RECIBEN BENEFICIOS DE CALFRESH IMPORTANTE — FAVOR DE LEER

A partir del 1° de octubre, 2016, las leyes estatales y federales estipulan lo siguiente:

Asignaciones máximas de beneficios del Programa de CalFresh: Estas son las cantidades de beneficios que su hogar recibiría si su hogar no tuviera ingresos.

- La asignación de \$143.00 para alojamiento/albergue para personas sin hogar permanecerá igual.

La cantidad normal permitida de \$385.00 para servicios públicos (*Standard Utility Allowance* - SUA) aumentó a \$389.00.

La cantidad limitada permitida de \$118.00 para servicios públicos (*Limited Utility Allowance* - LUA) aumentó un poco a \$122.00

Si la SUA/LUA se usa como parte de su deducción por vivienda y no ha tenido cambios en su caso de CalFresh, es posible que haya un cambio en sus beneficios de CalFresh. Con los cambios en sus beneficios de CalFresh, la cantidad que recibirá dependerá de otros cambios en su hogar. Estos cambios se incluirán en cualquier notificación que reciba indicándole otros cambios en sus beneficios de CalFresh.

Si cree que cometimos un error al calcular la cantidad de sus beneficios de CalFresh correspondientes al mes de octubre, debido a las nuevas cantidades de las asignaciones y la SUA/LUA, puede pedir una audiencia con el Estado *dentro de 90 días a partir de la fecha en que recibió esta carta*, escribiendo a:

Cuando pida una audiencia con el Estado, tendrá que decirnos por qué cree que cometimos un error. Puede representarse a sí mismo en la audiencia o lo puede representar un amigo, abogado u otra persona, pero usted tiene que pedirles a esas personas que le ayuden. Puede pedir asistencia legal gratuita en una oficina de asesoramiento legal en el área donde usted vive.
