SUBJECT: SELF-ESTEEM WITH RESPECT TO FOSTER CHILDREN

REFERENCE: WELFARE AND INSTITUTIONS CODE SECTION 16001.5 HEALTH AND SAFETY CODE SECTION 1529.2

Pursuant to the implementation of Senate Bill 916 (Chapter 542, Statutes of 1997) the California Department of Social Services is responsible for annually distributing information declaring the importance of promoting self-esteem in foster children.

Research shows that building a child's self-esteem increases that child's ability to achieve in school, work, and life activities, while conversely decreasing delinquent behavior, including violent acts, teenage pregnancy, drug and alcohol abuse, as well as dropping out of school. Promoting self-esteem encourages the child to be responsible for making moral decisions and enhances the child's capability to meet his/her own needs.

A child's developmental needs are met in part through the building of self-esteem. A positive self-esteem is generally accompanied by a feeling of security, along with emotional and physical growth. Part of our goal in the foster care home, agency, or institution is to provide children with a safe, nurturing environment where they can heal, grow and develop.

Thus, as stated in the Health and Safety Code section 1529.2, all foster parents are required to be trained in positive discipline and the importance of self-esteem as part of their 12 hours of preplacement training and their eight hours of postplacement annual training.
