SUBJECT: INDIAN HEALTH CLINICS (IHC) PROGRAM

California's Native American population experiences high rates of substance abuse and mental health issues that pose significant barriers to obtaining employment and attaining self-sufficiency. Cultural barriers and other issues, however, have also prevented Native Americans who are eligible for Temporary Assistance to Needy Families (TANF) from participating in welfare-to-work activities.

To address this problem, the California Department of Social Services (CDSS) entered into a collaborative agreement with the Department of Alcohol and Drug Programs (ADP) to provide culturally relevant substance abuse and/or mental health services to Native Americans who are either applying for, or participating in, California Work Opportunity and Responsibility to Kids (CalWORKs) or the Tribal TANF Program. Contracts with the IHCs were implemented on November 1, 2001, and 30 designated clinics were approved to receive funding to provide appropriate services to eligible tribal participants.

Clinics provide the culturally relevant substance abuse and mental health services necessary for tribal participants to obtain or retain employment, or to participate in county CalWORKs or Tribal TANF welfare- to-work activities. Services provided by the clinics may include the following:

- Outreach to and identification of individuals who are receiving, or may be eligible for, CalWORKs cash assistance;
- Outreach and screening individuals for substance abuse and/or mental health issues;
- Ensuring that individuals have transportation to the county welfare department to apply for CalWORKs cash assistance and/or participate in welfare-to-work activities;
- Accompanying individuals to the evaluation for mental health and/or substance abuse services;

- Providing individual or group services or making referrals to more intensive treatment services offered by the county welfare department or by county alcohol and drug program services; and
- Facilitating the integration of individuals into the CalWORKs Program.

To help increase tribal member participation in the IHC Program and CalWORKs, we encourage counties to refer tribal members who are current or potential CalWORKs recipients to a participating IHC when the county determines that they may benefit from IHC Program services. A listing of the participating IHCs and their locations is enclosed. For Fiscal Year 2002-03, we anticipate contracting with additional IHCs in areas of the State that are currently underserved. We will notify you once contracts have been executed with those additional clinics.
