SUBJECT: CALFRESH: USE OF CORRECTED CALWORKS GRANT AMOUNT WHEN DETERMINING A CALFRESH OVERISSUANCE OR UNDERISSUANCE

REFERENCE: <u>ALL COUNTY LETTER (ACL) NO. 03-18; ACL NO. 12-25; ACIN</u> NO. I-16-05; TITLE 7 CODE OF FEDERAL REGULATIONS (CFR) <u>SECTION 273.18; MANUAL OF POLICIES AND PROCEDURES</u> <u>SECTION 63-801.312</u>

This erratum provides clarification regarding the calculation of a CalFresh Overissuance (OI) or Underissuance (UI) when there is a California Work Opportunity and Responsibility to Kids (CalWORKs) overpayment based on the same period and case circumstances. The guidance provided applies to both administrative errors (AE) and inadvertent household errors (IHE).

BACKGROUND

<u>All County Letter No. 03-18</u> provides that when determining the value of either an AE or IHE OI or UI, the County Welfare Department (CWD) must recreate case circumstances by using the CalWORKs grant amount the household *should* have received had the household reported the required information and the county taken timely action. <u>All County Information Notice (ACIN) No. I-16-05</u> provided incorrect guidance on this same topic (question and answer page 12). This erratum corrects ACIN 1-16-05 and

reiterates guidance provided in ACL No. 03-18. This correction is effective as of the date of release of this letter.

CURRENT POLICY

The statement in <u>ACL No. 03-18</u>, bottom of page 69 and top of page 70, regarding the use of the corrected CalWORKs grant amount when determining the value of a CalFresh OI or UI is correct. Even though <u>ACL No. 03-18</u> provides this guidance within the context of quarterly reporting, the guidance is still accurate under semi-annual reporting.

When determining the value of a CalFresh OI or UI, the CWD must use both the CalFresh and CalWORKs amount the household *should* have received had the household reported the required information and the county taken timely action.

RE-CALCULATION OF EXISTING CLAIMS

Households with established claims as of the release of this letter may request a recalculation using the methodology clarified above. For those OIs or UIs that are in the process of being calculated as of the release of this letter, the methodology clarified above must also be used.
