Scott founded the Hannah Rose Foundation to increase awareness and educate people about the fatal consequences of Shaken Baby Syndrome and child abuse.

This annual event reflects CDSS' commitment to strengthening families and preventing child abuse by helping to raise awareness about child abuse prevention and by honoring individuals dedicated to assisting children who have experienced abuse and neglect.

"Kids' Day at the Capitol" will be another blockbuster event, attracting many dignitaries, law enforcement, firefighters, and various community groups from around the State. A sample of invitees includes the California's Child Abuse Prevention Councils, family

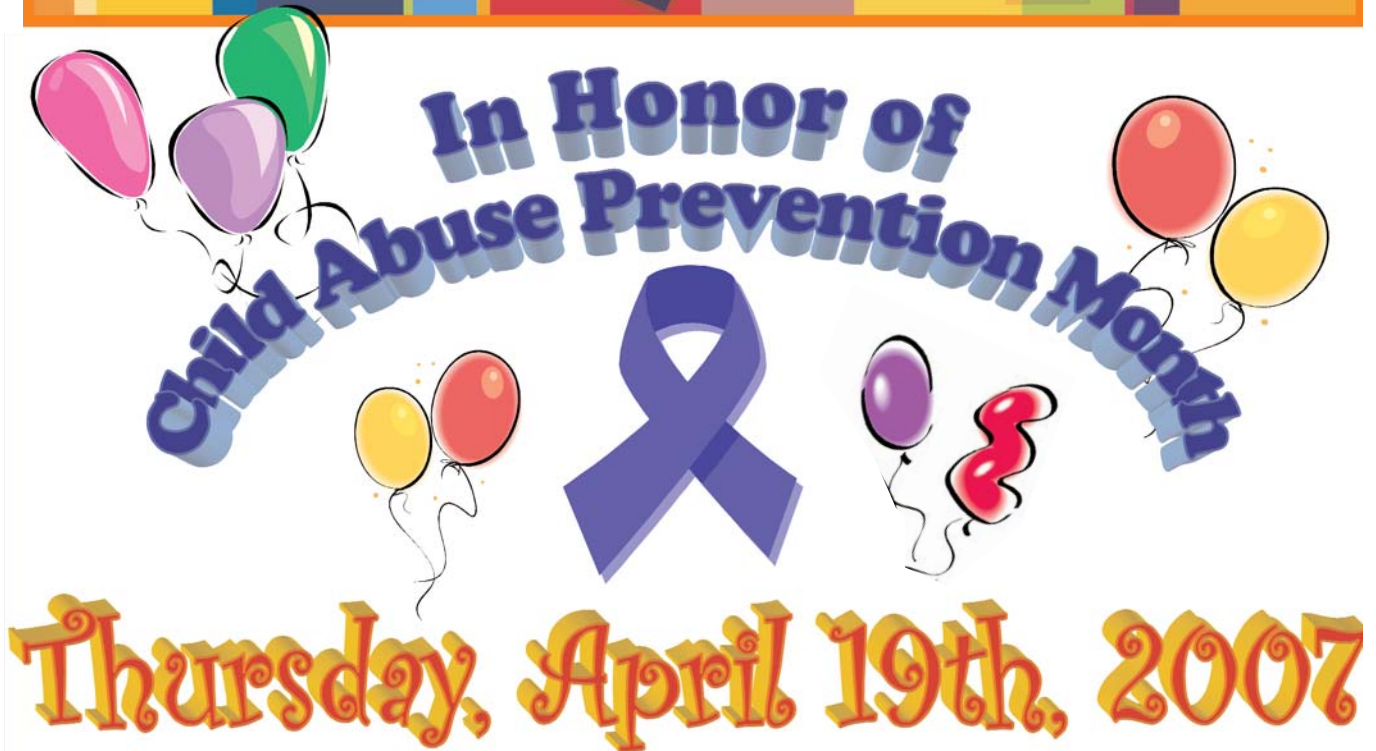
