SUBJECT: Food Stamp Regional Workshop

REFERENCE:

The purpose of this letter is to inform you that the Food Stamp Program Management Branch (FSPMB) will be conducting Regional Workshops covering the Food Stamp Reform Regulations. As you are aware, the reform regulations will be effective March 1, 1979. The purpose of the Regional Workshops will be to provide an overview of the major provisions of these regulations for your program specialists, food stamp trainers and program administrators. The more complex provisions of the reform regulations will be covered, with special emphasis placed on those areas differing significantly from current requirements.

Due to the limited size of our accommodations, we request that counties restrict the number of staff attending the workshops to a maximum of three (3) persons. The locations, dates and times of the workshops are as follows:
