SUBJECT: ASSISTANCE EXPENDITURE CLAIMING INSTRUCTIONS EFFECTIVE WITH THE  
CLAIMS FOR JULY 1980

This is to provide counties with interim information relative to the preparation and submission of the following assistance expenditure claiming forms:

CA 800

1. Form CA 800 is being revised to change the percent which is used to determine the state share in the increase in maximum aid effective January 1, 1977, as reported in Line 20F, from 4.67 to 4.04. Until the revised Form CA 800 is available, please use the current form and manually change the percent to 4.04.
2. There has been a delay in the approval of the revised repayment sharing ratios. When reporting repayments in Line 23 of the CA 800, please use current sharing ratios when reporting federal, state and county shares. These amounts will be adjusted by our desk audit staff when the new ratios are finalized.

CA 800 BHI (Fed) and CA 800A BHI (Nonfed)

1. An initial supply of the revised forms has been mailed. If your county did not receive a supply, please call one of the numbers listed below.
2. Because of the separate AFDC-BHI claims, current repayment ratios can not be used. Therefore, we are requesting that the reporting of AFDC-BHI repayments be delayed until the new ratios are available.

Form DFA 814


The Form DFA 814 - Nonfederal Share of Expenditures for Cuban Refugee/Indochinese Refugee Assistance Program Recipients Converted to AFDC-BHI is being revised to meet new federal reporting requirements. Until a revised Form DFA 814 is available, please use the current form. When using the current form for reporting expenditures in behalf of federally eligible Cuban/Indochinese Refugee children, cross off Items 1, 3, 4 and instructions shown for Item 5 (i.e., Item 1 x Item 4). When using the form for reporting expenditures in behalf of nonfederal Cuban Refugee children, cross off Items 1, 2, 4, 5, 6 and instructions shown for Item 7 (i.e., Item 5 minus Item 6).

AD 800A

It will be necessary to include the persons count and total aid as reported on Line 12 of both the Form CA 800 BHI (Fed) and Form CA 800A BHI (Nonfed) in Line 13, Col. A and B, of Form AD 800A. It is our intent to revise Form AD 800A to reflect this change when a new supply of the form is run.
