This letter is to inform you of a change in Food and Nutrition Service (FNS) reporting requirements. The Western Regional Office of the FNS is now the official accounting station for the Food Stamp Program. All FNS reports that are currently sent to the FNS national office should be forwarded to the FNS Regional office at the following address:

Warrants for FNS 250 liabilities and/or justification for FNS 250 billing adjustments should also be submitted to the above address. Counties must also continue to submit to SDSS copies of all warrants and/or correspondence which are submitted to FNS regarding FNS 250 liabilities.

It should be noted that there is no change in the information being reported on any of the reports, nor is there a change in the forwarding of any required copy of these reports to SDSS. The new reporting procedures are effective for all reports listed in the attachment that are due April 1, 1982 and afterwards.

If any of the reports in the attached list have been submitted between April 1, 1982 and the date of this notice, County Welfare Departments must insure that a copy is or was forwarded to the FNS Regional Office. All reports that are completed after the date of this notice will not require a copy to be forwarded to the FNS National Office.
