SUBJECT: DIRECTORY OF FEDERAL AND STATE PRISONS AND INSTITUTIONS

To assist County Welfare Departments to meet the requirement to provide Family Reunification services to incarcerated or institutionalized parents as specified in Welfare and Institutions Code (WIC) Section 361.5(e), the State Department of Social Services has compiled a directory which provides information on locating persons who may reside in such facilities, the addresses of facilities, and the name and telephone number of a person at each location who may be contacted for further information. This listing was created with the assistance of the Federal Bureau of Prisons, the State Departments of Mental Health, Corrections, and Developmental Services, and the California Youth Authority,

County Welfare Departments may contact designated staff at the various facilities to determine the facilities' current policies regarding visitation with persons in the facilities. Arrangements for children to visit or to contact their parents should be made in advance and on a case-by-case basis as visiting hours and procedures vary from institution to institution, and particularly in the case of correctional facilities, may change based on the prisoner's standing or the facility's status.

Federal Correctional Facilities

To locate an inmate in a Federal correctional facility in California who was sentenced in 1979 or later, call the Bureau of Prisons, Community Programs Office, at (916) 551-2833. If an inmate was sentenced prior to 1979 or is believed to be incarcerated in a Federal facility outside California, contact the Bureau of Prisons, National Locator Service, at (202) 724-3126. These locator services require the inmate's full name and Federal Register number, if known. If the Federal Register number is not known, a search may be conducted based on the inmate's name and date of birth, Social Security number, or Federal Bureau of Investigation number.
