SUBJECT: EARNED INCOME CREDIT OUTREACH CAMPAIGN

ALL COUNTY INFORMATION NOTICE NO.s I-04-94, dated REFERENCE:

The purpose of this letter is to transmit copies of the Earned Income Credit (EIC) outreach flier, envelope stuffer and fact sheet. The Center on Budget and Policy Priorities prepared the outreach materials for distribution to all state human service agencies. This year's campaign focuses on increasing participation, reaching a new population, encouraging people to use free, tax preparation services and marketing advance payments.

The earned income credit does not count as income in determining eligibility or benefit levels for the Aid to Families with Dependent Children, Food Stamp, Supplemental Security Income and Medi-Cal programs or most federally assisted housing programs. Therefore, recipients of these programs, as well as families receiving child welfare services, foster parents and adoptive parents, will benefit by applying for and receiving an earned income credit. Also for the first time, adults with no children, such as In-Home Supportive Services' providers may qualify for the earned income credit.

The earned income credit increases economic resources available to low-income working people. The effect of the benefit may be significant to families who enter the child welfare services system due to a lack of food, shelter and clothing resulting in the neglect of their children. Counties should incorporate information on the earned income credit as part of providing preplacement preventive services and family preservation services to families who enter, or are at risk of entering, the child welfare services system.

Counties should also inform foster parents and adoptive parents that a foster child and a child receiving Adoption Assistance Program payments are considered a qualifying child for purposes of receiving the earned income credit. Since many foster parents and adoptive parents are unaware of their eligibility for this credit, counties should incorporate information on the earned income credit as part of their foster parent and adoptive parent recruitment efforts.

A separate Medi-Cal mailing will not be feasible this year, due to the conversion to the plastic Medi-Cal cards, so the California Department of Social Services (CDSS) is distributing these materials earlier to give counties adequate lead time to inform clients. Attached is a revised version of last year's Medi-Cal stuffer with the "Work Pays" logo as an optional stuffer. Counties should include either stuffer with the AFDC warrants. These materials are not required forms and will not be stocked by the CDSS. Copies of the flier, envelope stuffers and fact sheets in English and Spanish are attached. A camera-ready copy of the flier, envelope stuffers and fact sheets in Cambodian, Chinese, Lao and Vietnamese will be sent to the county Forms Coordinators under separate cover by the Language Services Bureau.

Research shows that many people do not claim the earned income credit because they are either unaware of the credit or they complete the wrong tax form. Generally, a person can file an amended tax form (1040X) with the Schedule EIC for up to three years. The IRS offers free tax preparation through a program called VITA (Volunteer Income Tax Assistance). IRS' Regional Coordinators (see attached list) can provide information about VITA locations and the availability of free electronic filing. Additionally, counties can obtain a limited supply of brochures and posters from these locations free of charge.


Claim Your Earned Income Credit

A Tax Benefit for People Who Work!

The Earned Income Credit is a special tax benefit for people who work full- or part-time. If you qualify, you'll owe less in taxes, and you may get cash back. Even if you don't owe income tax you can get the credit. But, you must file a federal tax return.

Who can get the Earned Income Credit?

- Single or married workers who were raising children in their homes, and who earned less than \$25,296 in 1994 (or less than \$23,755 if they were raising only one child). File form 1040 or 1040A, attach Schedule EIC.
- Single or married workers at least age 25 and under age 65, who were not raising children in their homes, and who earned less than \$9,000 in 1994. File any tax form.




Earned Income Credit Envelope Stuffer

You could be eligible!

Did you work in 1994? You may be eligible for the Earned Income Credit. If so, you'll owe less in taxes, and you could get cash back. Even if you don't owe income tax, you can get the EIC!

- Were you raising one child in your home in 1994? Did your family earn less than \$23,755? You can get up to **\$2,038.**
- Were you raising more than one child in your home in 1994? Did your family earn less than \$25,296? You can get up to \$2,528.
- • If you weren't raising a child, did you earn less than \$9,000 in 1994? Were you between ages 25 and 64? You can get up to **\$306.**

Here's how you get it:

- If you were raising children in 1994, file federal tax return Forms 1040 or 1040A, not Form 1040EZ. Be sure to attach Schedule EIC.
- If you weren't raising children in 1994, just file any federal tax return.

Good news! In almost all cases, the EIC does not affect benefits like AFDC, food stamps, SSI, Medicaid or public housing.







The two-sided EIC envelope stuffer is easily reproduced on an office copier. There are two stuffers on each page to save you money on paper and copying. Make copies on one side, then turn your paper over and run it throught again to have stuffers with English on one side and Spanish on the other. When trimmed, the stuffers should fit in just about any size envelope.






If you lived with one child in 1994 and your family earned less than \$23,755, you can get up to \$2,038.



If you lived with two or more children in 1994 and your family earned less than \$25,296, you can get up to \$2,528.



If you had no children living with you in 1994 and you earned less than \$9,000, AND you were between ages 25 and 64, you can get up to \$306.

Yes!! The Earned Income Credit (EIC) is a special tax benefit only for people who work full- or part-time. If you qualify, you'll owe less in taxes and you may get cash back. Even if you don't owe income tax you can get the EIC. But, you must file a tax return. Starting this year, even workers who aren't raising children can get the EIC!




Get the Earned Income Credit By Filing a Federal Tax Return

If you were raising children in your home in 1994: File Form 1040 or 1040A, not Form 1040EZ. Be sure to attach Schedule EIC.

If you were not raising children in your home in 1994: File Form 1040, 1040A or 1040EZ. You don't need to file Schedule EIC.

Questions & Answers About the Earned Income Credit



To get free help filing your tax return and for more information about the Earned Income Credit, call the IRS at 1-800-829-1040.

What if I haven't filed a tax return in a long while?

You can still get the EIC. If you were eligible you can claim the EIC for three years back. Call the IRS to find out how. If you owe back taxes, the EIC may lower your tax bill. You may also be able to work out a payment agreement.

Can I get a quick refund with my Earned Income Credit?

Yes, but it might not be your best choice. Quick refunds take away money from your EIC. Remember, free tax help is available.

What if I'm not a U.S. citizen?

Many legal immigrants who are employed are eligible for the EIC, including *green card* holders, refugees, and others legally authorized to work. Getting the credit will not hurt your immigration status.

I work and get public assistance benefits. If I get the EIC, will I lose my other benefits?

In most cases no. The EIC does not affect benefits like AFDC, Food Stamps, SSI, Medicaid or housing.



¿Puedo recibir una devolución rápida con mi Crédito por Ingreso de Trabajo?


Sí, pero puede que no sea la mejor opción. Las devoluciones rápidas restan dinero de su EIC. Recuerde, puede conseguir asistencia gratuita sobre impuestos.

¿Qué ocurre si no soy un ciudadano de Estados Unidos?

Muchos inmigrantes documentados que están empleados califican para el EIC, incluyendo a quienes tengan la tarjeta verde, refugiados y otras personas autorizadas legalmente a trabajar. Recibir el crédito no afectará a su estado inmigratorio.

Yo trabajo y recibo beneficios de asistencia pública. Si recibo el EIC, ¿perderé mis otros beneficios?

En la mayoría de los casos, no. El EIC no afecta a los beneficios como el AFDC, cupones de alimentos, SSI, Medicaid o vivienda publica.



VITA, un programa del IRS, ayuda a aquellos interesados a llenar los formularios de impuestos gratuitamente. Las oficinas de VITA están abiertas desde finales de enero hasta el 15 de abril.
