# SUBJECT: WELFARE INTEGRITY - WELFARE ABUSE WORK GROUP

The purpose of this All-County Information Notice is to inform you of the accomplishments of the California Department of Social Services' Welfare Abuse Work Group. Because of the diligent efforts of its members, the Work Group has fulfilled its mission to advise the Department on improving the integrity of the Aid to Families with Dependent Children (AFDC) program in California.

To improve the integrity of California's welfare system, a Strategic Planning Task Force convened in October 1993. After three months of intensive effort, the task force identified 85 action steps to improve integrity. These steps were subsequently incorporated into the California Department of Social Services' (CDSS) Strategic Plan, <u>Bringing Integrity to Welfare in</u> <u>California</u>, which identified five broad areas of program improvement:

- Emphasizing prevention;
- Improving tools and technology to detect fraud;
- Increasing accountability through more effective penalties and better collection of overpayments;
- o Cracking down on program abuse; and
- o Refocusing program management to stress integrity, quality, and efficiency.



Several of the AFDC abuse problems identified in the strategic planning process required in-depth analysis. As a result, CDSS convened the Welfare Abuse Work Group to develop options for resolving these program abuse issues. The Work Group has assisted CDSS in completing the following:

Improved Eligibility Worker Use of Immigration and Naturalization Service Documents CDSS issued All-County Information Notice (ACIN) No. 6l-95 in December 1995 addressing the concern that many adults receive aid for children who are not really living with them. Among other options, the notice suggests that workers monitor situations more closely, refer cases to the Special Investigative Unit and consider a home visit to view children. CDSS revised both the AFDC Handbook (PUB 62) and the CA 1030 form to inform recipients that home visits may be conducted. The Handbook was distributed in December 1995. The CA 1030 is scheduled to be issued in January 1996.

Current federal and state regulations stipulate that persons applying for AFDC are required to provide a social security number (SSN) as a condition of eligibility. Concerns exist that if verification does not include obtaining a SSN, an excluded parent's income could be overlooked in computing the grant amount for the assistance unit. CDSS will issue an ACL during February 1996. The ACL will clarify that to the extent an SSN is available, it should be used to verify the excluded parent's income.

The revised AFDC Handbook (PUB 62) and the SAWS 2A also includes narrative that clearly states that a county worker can make unannounced home visits. The Handbook was distributed in December 1995. The SAWS 2A is scheduled to be issued in January 1996.

The Alien Guide was released with All County Information Letter I-47-95 on October 10, 1995.

#### Temporary Absence

#### Deeming Income of Excluded Undocumented Parents

#### <u>Solution</u>

Emergency regulations were transmitted to the counties in September 1995 with an effective date of December 1, 1995. These regulations implement a new federal Action Transmittal that clarifies priority order for collections.

Final regulations which limit temporary absences to one full calendar month, unless extenuating circumstances exist as defined in regulations, are projected to be effective June 1, 1996. In addition two forms are being revised (CA 7 and SAWS 7) to remind clients of the reporting requirements of temporary absences. The scheduled release date for the forms is January 1996.

A public hearing was held and testimony received in October 1995 on proposed regulations to reduce inequities between noncitizen parents and excluded parents in deeming income. The target effective date for the regulations is March 1, 1996.

### **II. LEGISLATIVE/WAIVER SOLUTIONS**

#### Issue Area

Misuse of AFDC Funds and Abuse of Homeless Assistance Payments (HAP)

Enforce Affidavit of Support of Sponsored Immigrants

#### Solution

The Governor signed AB 908 (Chapter 307, Statutes of 1995) which limits eligibility of temporary shelter and permanent housing assistance to once-in-a-lifetime, with certain exceptions. CDSS issued ACL 95-62, dated October 30, 1995, which implements these homeless assistance limitations.

The Governor signed AB 836 of (Chapter 196, Statutes of 1994) barring sponsored aliens from AFDC for five years contingent on a federal law change. CDSS appreciates the Work Group's resolute efforts to assist the Department in fulfilling its strategic plan to bring integrity to the AFDC program. Any future issues will be addressed by CDSS in consultation with the County Welfare Directors' Association (CWDA) and the California Welfare Fraud Investigators Association (CWFIA)
