SUBJECT: NOTICE OF ACTION (NOA) INDEX FOR THE AID TO FAMILIES WITH  
 DEPENDENT CHILDREN (AFDC) AND CERTAIN CHILD CARE  
 PROGRAMS

The purpose of this letter is to provide an updated NOA Handbook Index. The last update was issued in the AFDC NOA Handbook, Update Package #9104 dated September 20, 1991. New and revised NOA messages and NA forms will continue to be issued as attachments to All County Letters or All County Information Notices (ACL/ACIN). As NOA messages and NA forms are transmitted via ACL/ACIN, counties should continue to update their NOA Handbooks.

We modified the last updated index and included NOA messages and NA forms issued since that time to show the transition to current date. The NOA messages and NA forms no longer in use are lined out with the reason and the issuing letter. As index updates are issued, the prior NOA messages and NA forms that were lined out will be removed and put on a separate "obsolete" list for historical purposes. Also included in this index are the California Alternative Assistance Program, Greater Avenues for Independence, Supplemental Child Care and Transitional Child Care NOA messages and NA forms.
