The purpose of this letter is to provide counties with information and instruction on the impact of the court order issued on February 23, 2010, in the case of the <u>California Alliance of Child and Family Services v. Cliff Allenby, et.al.</u> as it relates to the Adoption Assistance Program (AAP).

#### **COURT RULING**

The District Court ordered the California Department of Social Services (CDSS) to adjust the group home rates paid under California's Rate Classification Level (RCL) system in effect January 1, 2008, to reflect the California Necessities Index (CNI) increases from 1990-91 through 2009-10. The cumulative increase for that period was determined by the Court to be 76.25 percent. After consideration for CNIs that have been given over that same period, increases ranging from 32 percent to 40 percent

were applied to the group home rates in effect January 1, 2008. Therefore, effective immediately and retroactive to December 14, 2009, counties shall pay the rates reflected in the chart below for both federally eligible and non-federally eligible children in group home placements. The CDSS will amend this schedule annually to reflect changes in the CNI and such adjustments will not be subject to the availability of funds.

## ADOPTION ASSISTANCE PAYMENTS

The AAP payment may not exceed the maximum state-approved foster care facility rate. Consequently, AAP agreements for out-of-home placements must reflect the retroactive rate increases effective December 14, 2009. The AAP benefit increase to the state-approved foster care facility rate requires the concurrence of the adoptive parent(s) and must be reflected in a new AAP agreement for the limited duration of the child's out-of-home placement. As a reminder, AAP payments for out-of-home placements may not exceed eighteen months per episode or condition pursuant to Welfare and Institutions Code section 16121(b).

#### **OUT-OF-STATE PLACEMENTS**

For AAP eligible children placed in an out-of-home placement in another state, the rate to be paid shall be the rate established by the rate-setting authority of the other state. The AAP payment shall not exceed the current fiscal year's RCL 14 as reflected in the above schedule of rates and subject to subsequent annual CNI augmentation.

### WRAPAROUND PROGRAM

AAP payments may not exceed the corresponding Wraparound rate applicable for the services the child receives. Any change in the amount of AAP requires the concurrence of the adoptive parent(s) and must be reflected in a new AAP agreement.
