MESSAGE: As of _____, the county is stopping your cash aid.

Here's why:

You got a lump sum of money in _____. The money you got will meet your family's needs for the number of months shown on this notice. Your family's needs and income are figured on this notice.

You may get short-term State-U (State AFDC Unemployed Parent Program). You must apply for it. A family can only get State-U for 3 months in any 12 month period.

You may also get a supplemental payment, if you apply for State-U before your cash aid is stopped. You must use a Reduced Income Supplemental Payment Request Form (CA 40). If you don't have a CA 40, call this office and ask for one.

If nothing changes, you can't get Federal AFDC until _____. You must ask for it.

If something changes, or a family member moves into your home, or if you have an emergency, you may be able to get Federal cash aid sooner. Call your worker or come into this office right away.

INSTRUCTIONS: Fill in the blank spaces. Explain in the right hand column the computation of the client's needs and income and the lump sum POI.

May be used when the client could be eligible for a one month suspense period and a supplemental payment.
