This letter, which replaces All County Information Notice (ACIN) No. I-112-88, provides an updated list of Food Stamp informational materials. The posters (PA 1240, FNS 183, and TEMP 1764 and Census poster) must be posted in the Food Stamp and Public Assistance offices. The remaining required materials must be made available in those same offices. The PA 1340 is not required but it is a recommended resource for applicants as it provides a great deal of valuable applicant/recipient information, including rights and responsibilities.

- o PA 1241 (8/86) a pamphlet titled "Building A Better Diet"

- o PA 1346 (7/84) a pamphlet titled "Eat A Variety of Foods"  
OR
- o PA 1347 (7/84) a pamphlet titled "Plan Ahead to Make Your Food Dollars Count"
- o Census Poster a flyer from the United States Department of Commerce

Optional

- o PA 1340 (9/89) a pamphlet titled "Facts about the Food Stamp Program"

Expiration Dates

There is an expiration date of June 30, 1990 for the TEMP 1764 and August 31, 1990 for the Census Poster. There is no expiration date for any of the other informing materials.
