SUBJECT: TEMP 2052, THE "IT PAYS TO WORK" STUFFER

REFERENCE: All-County Letter No. 93-49, Dated July 7, 1993

This letter transmits the TEMP 2052, the "It Pays to Work" stuffer. The TEMP 2052 supplements information in the TEMP NA 3 Informing Notice that was transmitted in All-County Letter No. 93-49. The TEMP 2052 is intended to encourage recipients to work, even part-time. This stuffer provides information on the \$30 and 1/3 earned income disregards, child care disregard, and the budgeting process. The TEMP 2052 also references a new program, Supplemental Child Care (SCC) Program, to be effective November 1, 1993. Additional information about the SCC Program will be provided under separate cover.

The TEMP 2052 is a required stuffer that can be sent with any October mailing, such as the warrants, CA 7/ SAWS 7s, Notices of Action (NOAs) or by separate mailing.

APDP RESEARCH COUNTIES (Los Angeles, San Bernardino, Alameda, and San Joaquin)


Cases assigned to control status will not be subject to the change in the \$30 and 1/3 earned income disregards. Therefore, it is not recommended that this stuffer be sent to control cases. However, if this is not feasible, then APDP research counties have the option (1) to send a letter under separate cover to the control cases advising them that the \$30 and 1/3 earned income disregards' change does not apply to them; or (2) to add a statement at the bottom of the stuffer that the \$30 and 1/3 earned income disregards' change does not apply to them.
