COUNTY FISCAL LETTER (CFL) NO. 08/09-08

TO: ALL COUNTY WELFARE DIRECTORS ALL COUNTY WELFARE FISCAL OFFICERS

SUBJECT: FISCAL YEAR (FY) 2007-08 CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS (CalWORKs) SINGLE ALLOCATION AUGMENTATION

REFERENCE: CFL NO. 07/08-21, Dated September 26, 2007 CFL NO. 07/08-32, Dated December 17, 2007 CFL NO. 07/08-49, Dated April 23, 2008

This letter is to notify counties of the revised CalWORKs Single Allocation for FY 2007-08. The revised allocation includes the remaining unspent balance of the \$90 million CalWORKs Improvement Program funds carried forward from FY 2006-07. In accordance with Assembly Bill 1808 (Chapter 75, Statutes of 2006), these funds were made available as a \$90 million augmentation to the CalWORKs Welfare-to-Work Employment Services allocation through June 30, 2008 and may be used for the purpose of identifying and implementing actions that will improve work participation rates among CalWORKs applicants and recipients. This may include improvement in the areas of initial engagement and reengagement by sanctioned and non-participating individuals.

Attachment I displays the distribution of the \$37,058,599 remaining balance for each county of the \$90 million CalWORKs Improvement Program funds carried forward from FY 2006-07 and the revised FY 2007-08 CalWORKs Welfare-to-Work Employment Services Allocation. Attachment II provides the revised total FY 2007-08 CalWORKs Single Allocation.
