I. SOCIAL SERVICES

A. Assembly Bill (AB) 1512—Health Benefit Determination

When foster children are placed out-of-county, they face existing and ongoing health care barriers which interfere with access to routine medical care, non-emergency mental health services, dental care, prescription medications; and also causes providers to mistakenly deny children their health care benefits. AB 1512 mandates counties to develop urgent disenrollment determinations and procedures for foster children enrolled in a county organized health system who are placed out-of-county. A determination must be made no later than one working day after an out-of-county placement begins. If it is determined that the child should be disenrolled, the county welfare department is required to submit a request to the appropriate entity that the child be disenrolled.

Time Study Instructions

Effective with the March 2009 quarter, counties will time study to Time Study Code (TSC) 7161 for activities performed by CWDs to make disenrollment determinations and to request disenrollment from a county organized health system for foster care children placed out-of-county.

Claiming Instructions

Effective with the March 2009 quarter, the following Program Code (PC) and associated Program Identifier Numbers (PINs) are made available to capture all costs associated with the health benefit determination requirement. The nonfederal costs will be shifted to State Use Only Code (SUO) 717.

Federally eligible costs will be funded at 50/50/00 (fed/state/county). The county must have a Letter of Intent on file with CDSS to use Support/Operating PIN Codes (88-91).

II. CalWORKs

A. Nonfederal CalWORKs Eligibility Program Identifier Number (PIN) Code

Claiming Instructions

Effective the March 2009 Quarter, the following PIN is established to capture costs associated with medical exams for nonfederal CalWORKs cases. There is currently a PIN code (614014) available for counties to claim medical exam costs for federal cases, but there is no code available for nonfederal cases. When program code 616 was established, type of expense (TOE) code 14 was inadvertently omitted. This PIN is necessary to allow counties to claim medical exam costs for nonfederal CalWORKs cases.

When program codes 664, 665 and 685 were originally established, TOE codes 88, 89, 90 and 91 were inadvertently omitted. These PINs are opened to allow counties to claim operating costs.
