This CFL informs County Welfare Departments (CWDs) of instructions for providing the California Department of Social Services (CDSS) with expenditure information regarding the costs associated with Stage One Child Care, transportation, and ancillary expenses provided to participants in the TANF ECF SE program. For base counties (see Base Counties section on page two), the requested information covers quarterly county expenditures beginning with the December 2006 quarter through the September 2010 quarter; all other non-base counties (see Non-Base Counties section on page three) that operated a TANF ECF SE program will provide expenditures beginning with the September 2009 quarter through September 30, 2010.

In July 2010, CDSS received late guidance from the federal Administration for Children and Families (ACF) through a new question and answer published on their website, http://www.acf.hhs.gov/programs/ofa/recovery/tanf-faq.htm, allowing states to include supportive services costs in the TANF ECF SE program reimbursement requests. Due to the late federal guidance and for purposes of maximizing earned TANF ECF, CDSS is now requesting that counties identify the respective costs. Supportive services costs

that need to be identified include Stage One Child Care, transportation, and ancillary services provided to SE participants only. According to the ACF guidance, SE costs "may include related training or education as well, if necessary to meet the requirements of the job or to provide an opportunity for advancement, and as long as the subsidized job is the predominant activity."

SUPPORTIVE SERVICES EXPENDITURE SPREADSHEET

To minimize county workload, attached is a spreadsheet for counties to report their quarterly supportive services expenditures provided to TANF ECF SE participants for the requested time periods. The data needed for the spreadsheet columns are: quarter claimed; supportive services program identifier number (PIN) claimed to; the total amount claimed to the PIN; and the total claimed to Stage One Child Care, transportation, and/or ancillary services.

This spreadsheet will be used to determine the amount of TANF ECF funding the <u>state</u> will earn. The CDSS will not change or adjust the County Expense Claim (CEC) nor allow adjustment claims since these costs have previously been claimed to the CEC. Instead, this spreadsheet will be used to update and support estimates for the expenditures included in California's final TANF ECF application submitted to ACF in September and as back-up documentation for CDSS to earn additional TANF ECF funds.

For base counties, CDSS requests that the completed spreadsheets be returned no later than December 27, 2010. For non-base counties, CDSS requests that the completed spreadsheets be returned no later than January 4, 2011. If a county cannot make the requested due dates for data submittal or if a county does not have sufficient space to input data on the attached spreadsheet, please contact Glenn Tsang, at the above e-mail address or by phone at (916) 651-6806, no later than December 10, 2010.

BASE COUNTIES

Counties that operated a SE program in the base years of 2006-07 and 2007-08 must submit expenditure information for those supportive services. As described in CFL NO. 10/11-16, the base counties for which information is requested during the December 2006 through September 2010 time period are as follows:

NON-BASE COUNTIES WITH A TANF ECF SE PROGRAM

All counties with a TANF ECF SE program must report expenditure information for the quarters beginning with September 2009 through September 30, 2010, providing the county had supportive services costs as described above.

ADDITIONAL EARNED TANF ECF

The CDSS will provide counties with 50 percent of any TANF ECF that the state receives above the base expenditures for county SE Stage One Child Care and supportive services, and community college SE Child Care and supportive services. Although these funds are being provided to counties based on the county's Stage One Child Care and other supportive services provided to SE participants, any county that accepts these funds is required to spend them toward that county's share of the California Work Opportunity and Responsibility to Kids program grant costs, beginning with the July 2010 grants, until the funds are exhausted, or through June 30, 2011, whichever occurs first. Further information on distribution of these funds will be provided at a later date.

POST-TIPPER

The CDSS cannot guarantee full funding will be available for all TANF ECF costs incurred because the federal government has reached the "tipper" of \$5 billion. However, since CDSS has already received 98 percent of the grant request, it is anticipated that sufficient funds may be available assuming actual claims are less than the estimated amounts requested. The CDSS is still waiting for federal guidance in the event that full funding of TANF ECF costs is not available for reimbursement.
