- SUBJECT: UPDATED EARNED BASE YEAR EXPENDITURES FOR THE TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) EMERGENCY CONTINGENCY FUND (ECF): SUBSIDIZED EMPLOYMENT (SE)
- REFERENCES: CFL 10/11-16 DATED AUGUST 13, 2010 CFL 09/10-32 DATED OCTOBER 26, 2009

This CFL provides the County Welfare Departments (CWDs) with updated earned base expenditures for the TANF ECF SE program for funds earned in the first three quarters of Federal Fiscal Year (FFY) 2009.

## Earned SE Funds (October 2008 – June 2009)

Due to a potential shortfall in meeting the FFY 2007 statewide base for FFY 2010, CWD funds earned in the first three quarters of FFY 2009 must be used on SE expenditures in FFY 2010. This earned base is being updated to reflect the actual non-wage data received from the counties and replaces previous estimates.

Since retroactive claiming for TANF ECF SE was not allowed, the state collected nonwage expenditure data from the same counties who claimed wage subsidy costs to the Assembly Bill 98 Program Identifier Numbers (PINs) in the first three quarters of FFY 2009. The wage data from the PINs and non-wage data provided by the counties were combined for each of the three quarters of FFY 2009. The California Department of Social Services (CDSS), in conjunction with the County Welfare Directors Association (CWDA), determined the earned SE funds by quarter for FFY 2009 and spread it to eligible counties for use in FFY 2010. The equally distributed amounts must then be spent as shown in Attachment II of this letter. Attachment I is the FFY 2007 base which CFL No. 10/11-60 Page Two

remains the same as illustrated in CFL 10/11-16. For more information regarding the FFY 2007 base and the earned base, please see CFL 10/11-16 and CFL 09/10-32.

## Out-of-Sequence Claiming

Since the earned base has been updated, out-of-sequence claims will be processed by CDSS' County Claims Unit. Only the affected counties will be contacted to provide the required changes necessary to correct the claims. This will require immediate attention and is necessary to accurately adjust previous claims to the earned base PINs for all four quarters of FFY 2010.
