COUNTY FISCAL LETTER (CFL) 11/12-38

- SUBJECT: REVISED CLAIMING INSTRUCTIONS AND PROGRAM CODE TITLE CHANGES FOR THE TRAFFICKING AND CRIME VICTIMS ASSISTANCE PROGRAM (TCVAP)

This letter provides counties with revised claiming and time study instructions for the TCVAP program.

## **Background**

The Trafficking Victims Protection Act of 2000 (Public Law [PL] 106-386) and subsequent Trafficking Victims Protection Reauthorization Act (TVPRA) of 2003 (PL 108-193) extended eligibility for federally funded benefits and services to human trafficking victims and certain eligible family members. To receive federally funded benefits and services, adults must be certified as trafficking victims by the federal Office of Refugee Resettlement (ORR).

On January 1, 2007, Senate Bill (SB) 1569 (Chapter 672, Statutes of 2006) established TCVAP, a state-only program to extend interim benefits and services to trafficking victims prior to the victims' ORR certification. The TCVAP also extended benefits and services to noncitizen victims of human trafficking, domestic violence, and other serious crimes.

The benefits and services made available under TCVAP include TCVAP Cash Assistance, State Funded Employment Services, California Food Assistance Program (CFAP), Cash Assistance Program for Immigrants (CAPI), and State Funded California Work Opportunity and Responsibility to Kids (CalWORKs) program, including Welfare-to-Work Services.

## **Claiming Instructions**

Effective with the March 2012 quarter, program codes (PC) 713 and 714, titled <u>SB 1569 Noncitizen Administrative</u> and <u>SB 1569 Noncitizen Services</u>, respectively, have been re-titled to <u>TCVAP Noncitizen Administrative</u> and <u>TCVAP Noncitizen Services</u>.

Listed below are PCs 713 and 714, and the corresponding six-digit Program Identifier Numbers (PINs) for claiming TCVAP administrative and services expenditures. The above described costs will be claimed to the county expense claim accordingly:

Counties will utilize PC 713 to claim all administrative costs for the programs listed above with the exception of CFAP. Consistent with CFL 97/98-26, CFAP administrative costs are captured separately and should not be claimed to PC 713.

For PC 714, counties will claim all services costs for all identified programs.

The funding ratios for costs in PC 713 and PC 714 are 00/100/00/00 (Federal/State/Health/County). State Use Only Code 715 will be used to shift costs from the state General Fund to 100 percent county share if a county exceeds the TCVAP Noncitizen Allocation.

## **Time Study Instructions**

Effective with the March 2012 quarter, time study codes (TSC) 7140 and 7149 (see CFL 08/09-47) will no longer exist. These previous codes will be included in TSC 7141, which will condense time studying for all TCVAP services for both CalWORKs and TCVAP Cash Assistance recipients into one TSC.

Except for the PC 713 title change to <u>TCVAP Noncitizen Administrative</u>, the TSC 7131 is unchanged. Counties will time study to TSC 7131 for all administrative activities for all programs with the exception of CFAP. Consistent with the CFL 97/98-26, the CFAP administrative costs are captured separately and should not be time studied to TSC 7131.
