- SUBJECT: REVISED FEDERAL INCENTIVE FUNDS FOR POST-ADOPTIVE SERVICES ALLOCATION FOR FEDERAL FISCAL YEAR (FFY) 2002

The purpose of this letter is to provide counties with a revised FFY 2002 Federal Incentive Funds for Post-Adoptive Services Allocation for the period of October 1, 2001 – September 30, 2002. These funds are available for expenditure until September 30, 2002.

On September 11, 2001, California received an additional grant of \$4,030,572 in federal incentive bonuses from The US Department of Health and Human Services. This grant was part of an award of nearly \$11 million to 35 states and the District of Columbia for increasing the number of children adopted from public child welfare agencies.

The revised FFY 2002 allocation (Attachment) was calculated by combining the funds from the FFY 2002 allocation (CFL 01/02-33), which was based on adoptions finalized in FFY 1999, and the recently received adoptive bonuses based on adoptions finalized in FFY 2000.
