SUBJECT: Child Welfare Services (CWS) External Systems

REFERENCE: Administration for Children and Families (ACF), Office of Information Systems Management (OISM) Action Transmittal (ACF-OISM-001)

In February 2009, the California Department of Social Services (CDSS) requested each county to complete a survey delineating the CWS external systems in operation and/or developed by counties for the purpose of augmenting the CWS/CMS functionality to better support CWS. The purpose of this informational letter is to provide counties with the results of the survey analysis performed by the CDSS. In addition, this letter outlines the decisions and scope in regard to conversion and decommissioning of the CWS external systems. The CDSS requests that each county review the enclosed CWS external systems spreadsheet and follow the instructions outlined in this letter for submission of guestions and/or comments using the Uniform Response Form.

The CDSS reviewed the survey results and performed analysis for multiple purposes. This analysis provides CDSS with the ability to identify current CWS external systems and this work supports development of CWS/Web. The first analysis was conducted to ensure that the CWS/Web Request for Proposal requirements covered the CWS business needs. The second analysis was to determine if the CWS external systems may have data that should be converted as part of the CWS/Web Project. The third analysis was performed to determine if the CWS external system would be necessary after the implementation of CWS/Web. If it is determined the CWS external system will no longer be necessary after the CWS/Web implementation, the CWS external system is classified to be decommissioned.

A CWS external system is classified to be converted if the functionality and/or data, as described in the county survey, is not in CWS/CMS and if the functionality and/or data is planned to be available in CWS/Web (new single statewide State Automated Child Welfare Information System [SACWIS]).

A CWS external system is classified to be decommissioned if the functionality and data will be available in CWS/Web and the CWS external system is only used by CWS.

The analysis to determine the conversion and decommissioning of the CWS external systems is part of the CDSS' ongoing efforts to implement one statewide SACWIS compliant system supporting California's CWS. ACF and CDSS expect that all Child Welfare-related functionality and data as defined within Title IV-E, will be within CWS/Web.

The ACF further confirms that the risks and consequences for implementing CWS/Web without all the Child Welfare-related functionality within Title IV-E or maintaining duplicative CWS external system this includes, but is not limited to, the potential for retroactive federal sanctions and/or disallowance of all federal SACWIS funding for the entire State of California.

It is the intent of CDSS to issue a future All County Letter to provide further clarification on the strategy for decommissioning and data conversion. The final timeframes for the data conversion and decommissioning strategy will be established in concurrence with CDSS, Office of Systems Integration, Child Welfare Directors Association and the implementation contractor at the earliest possible date in order to expedite system transition and planning activities.

The spreadsheet with the results of the CWS external systems survey and the analysis described above is enclosed in this letter for your review. A Uniform Response Form has been enclosed in this letter for your convenience.
