STRATEGIES FOR INCREASING THE WORK PARTICIPATION RATE

STRATEGY SUMMARY SURVEY

This letter transmits the Senate Bill (SB) 84 (Chapter 177, Section 19, Statutes of 2007) strategy summary survey form and directions for submitting information for the Final Report to the Legislature.

Assembly Bill (AB) 1808 (Chapter 75, Statutes of 2006) enacted the Welfare and Institutions Code Section 10534, which required counties to review their existing California Work Opportunity and Responsibility to Kids (CalWORKs) Plan and submit an addendum to the California Department of Social Services (CDSS) detailing how the county will meet specified goals, taking into consideration the work participation requirements of Temporary Assistance for Needy Families (TANF) Reauthorization. In accordance with SB 84, CDSS prepared a written update to provide the Legislature with information gathered in January, 2008, regarding strategies counties included in their AB 1808 addenda. The update is currently in review. As soon as it is received by the Legislature, a copy will be sent to you.

SB 84 required counties to report on strategies that are designed for up-front engagement and sanction reengagement. The statute also required counties to report on the characteristics of their time-limited (Safety Net) populations. Therefore, CDSS has also asked that counties report on any strategies they have implemented to engage Safety Net families in welfare-to-work activities in an effort to better inform the Legislature of counties' efforts to help families who have exhausted their 60-month time limit on aid.

As a follow-up to the written update, CDSS will submit a thorough report of results of the counties' efforts at developing and implementing their strategies contained in their county plan addenda. The final report will be submitted to the Legislature on September 1, 2008. CDSS will prepare the final report using information received through the enclosed survey. Information is due to CDSS on June 13, 2008 describing how the strategies have impacted WPR, and the characteristics of their Safety Net population. If there has not been any progress or new data to report since January, it is not necessary to resubmit the survey; however, please let us know via email at Ryan.Fruchtenicht@dss.ca.gov.
