**SUBJECT: FISCAL YEAR (FY) 2001/02 ADOPTIONS COUNTY COUNSEL
(ACC) STATE GENERAL FUND (SGF) PLANNING ALLOCATION**

Contingent upon approval of the State Budget, the amount identified on the enclosed attachment is your planning allocation for the ACC Program. It is anticipated that a total of \$374 SGF will be made available upon approval of the FY 2001/02 Budget Act.

The allocation was calculated by applying a percent to total of the actual total expenditures as reported on the County Expense Claim for calendar year 2000.

The expenditures claimed as a direct charge to Program Identifier Number (PIN) Code 567052 or PIN 568052 on the quarterly County Expense Claim will be tracked against the allocation. Any expenditures exceeding the allocation will be shifted to the county share using State Use Only Code 512. During the close-out process, any surplus funds remaining will be redistributed to deficit counties.
