INSTRUCTIONS FOR THE FORM CA 800 FC FED PIA FOSTER CARE PLACEMENT INFORMATION ADDENDUM

Persons Count

- Line 1: Enter the total number of persons in Group Homes. This should match the CA800 FC1 Fed, Col J1.
- Line 2: Enter the total number of persons in Foster Family Agency (FFA) homes. This should match the CA800 FC1 Fed, Col D1.
- Line 3: Enter the total number of persons in Licensed Foster Family homes.
- Line 4: Enter the total number of persons in Approved Relative Homes.
- Line 5: Total Persons Count for the month (*Lines 1~4*). This amount will calculate automatically, and should match the total Foster Care 'Persons Count' on the CA800FC FED - Line 13.

Main Payroll

- Line 6: Enter the total maintenance payments for Group Home. This should match the CA800 FC1 Fed, Col J2.
- Line 7: Enter the total maintenance payments for FFAs. This should match the CA800 FC1 Fed, Col D2.
- Line 8: Enter the total maintenance payments for Licensed Foster Family Homes.
- Line 9: Enter the total maintenance payments for Approved Relative Homes.
- Line 10: Total Maintenance Payments for the Month (*Lines 6~9*). This amount will calculate automatically and should match the total Foster Care amount on the CA800FC FED - Line 13.

Prior Period Negative Adjustments

- Line 11: Enter the total Prior Period Negative Adjustment amount.
- Line 12: Enter the total Prior Period Negative Adjustment for all Approved Relative Homes.
- Line 13: Enter Total Prior Month Negative Adjustments for all Approved Relative Homes for the time period of January 1 ~ December 31, 2002. Do not enter adjustments resulting from the monitoring findings; those adjustments will be included on line 16 of the PIA.
- Line 14: Total Prior Period Negative Adjustments (*Line 11 less Line 13*). This amount will calculate automatically. Enter this total amount on Line 9 of the CA800FC FED.

Monitoring Adjustments

- Line 15: Enter the Prior Period Adjustments for unallowed placement costs due to the monitoring efforts, for the time period of January 1 ~ December 31, 2004.
- Line 16: Enter the Prior Period Adjustments for unallowed placement costs due to the monitoring efforts, for the time period of January 1 ~ December 31, 2003.
- Line 17: Enter the Prior Period Adjustments for unallowed placement costs due to the monitoring efforts, for the time period of January 1 ~ December 31, 2002.
- Line 18: Total Office Audit Corrections for the month (*Lines 15~17*). This is the total adjustment amount for all unallowed placement costs due to the monitoring efforts. This amount will calculate automatically and should match the total amount on the AC42FC Adjustment Worksheet and the CA800FC Fed, Line 12.
