SUBJECT: COUNTY WELFARE DEPARTMENT (CWD) ADVANCE PAYMENTS TO SUPPORT THE GOLDEN STATE GRANT PROGRAM

## REFERENCE: <u>SENATE BILL (SB) 88 (CHAPTER 8, STATUTES OF 2021)</u>

The purpose of this All County Welfare Directors Letter (ACWDL) is to provide CWDs with information regarding the advances for the Golden State Grant program payments to California Work Opportunity and Responsibility to Kids (CalWORKs) assistance units (AUs), pursuant to SB 88 (Chapter 8, Statutes of 2021), signed by the Governor on February 23, 2021. The advances assist counties with cash flow to provide additional financial relief for low-income Californians who may have been adversely impacted by the economic disruptions resulting from the COVID-19 pandemic.

CWDs will receive an advance of state General Funds to support the costs associated with issuance of the Golden State Grant payments as part of their regular County Administrative advance on March 15, 2021. The advances will be identified as "Golden State Grant advances" on the AA-190 and are included as Attachment I to this letter. The California Department of Social Services (CDSS) has determined each county's advance payment based on CalWORKs case counts from the CA 237 CW report multiplied by the \$600 one-time payment to eligible CalWORKs AUs. A five percent increase was added to each county advance amount to support adequate cashflow.

Guidance on the treatment of the Golden State Grant payments in the CalWORKs program and the claiming details will be issued under All County Letter (ACL) 21-23 and a separate County Fiscal Letter (CFL), both to be published at a later date.
