~~The Federal Fiscal Year 2019 waiver of the ABAWD time limit will continue through August 31, 2019, unless a county notifies CDSS via a letter from its County Board of Supervisors, indicating its intent to pursue opting out of the waiver of the ABAWD time limit. If any county declines to participate in the waiver, it must inform CDSS within two weeks of the issuance of this letter.
