# Screening Tool and List of Gender Affirming Providers in California for Assisting Transgender and Gender-Nonconforming (TGNC) Minor and Nonminor Dependents in Foster Care

#### I. SCREENING TOOL

This screening tool provides specific questions to ask medical and mental health providers to help social workers, probation officers, and caregivers determine whether they are qualified and competent to provide gender-affirming care. Aside from practical experience, the most important qualification is compassion toward, and acceptance of, TGNC children, youth, and young adults.

### **Level of Experience:**

- 1. Do you have any patients who identify as transgender or gender non-conforming?
  - a. If so, what is the age range of your patients?
  - b. How long have you been treating transgender and GNC patients?
  - c. How many transgender or GNC patients have you treated?
  - d. Do you have experience providing GNC youth/young adults with referrals to gender-affirming provider for other types of healthcare services GNC youth/young adults may need?
  - e. For medical providers: do you have experience writing letters supporting a GNC patient's efforts to correct their identity documents?
  - f. For mental health providers: do you have experience writing letters documenting a patient's readiness for puberty-delaying medications and hormone-replacement therapy?
- 2. Does your practice have policies to ensure staff use the correct names and pronouns for transgender and GNC patients?
  - a. How long has that policy been in effect?
  - b. Has the staff been informed of that policy?
  - c. Has the staff been trained on the implementation of that policy?
- 3. For medical providers who haven't treated transgender or GNC youth/young adults, do you have experience with the following:
  - a. Prescribing and monitoring pediatric patients on GnRH analogues; and
  - b. Prescribing and monitoring pediatric patients on estradiol or testosterone.

### Level of Knowledge:

- 1. Are you familiar with any of the following:
  - a. The Standards of Care published by the World Professional Association for Transgender Health (WPATH);
  - b. Endocrine Treatment of Gender-Dysphoric/Gender-Incongruent Persons: An Endocrine Society Clinical Practice Guideline; or

- Ensuring Comprehensive Care and Support for Transgender and Gender Diverse Children and Adolescents, published by the American Academy of Pediatrics.
- 2. Have you ever participated in continuing education programs about transgender or GNC youth?
  - a. How many programs?
  - b. Who provided or delivered those programs?
  - c. And, on what topics?
  - d. How recently have you taken that program?

#### **Level of Interest:**

- 1. Would you be willing to collaborate with a provider who has experience working with transgender and GNC youth/young adults?
- 2. Would you be willing to attend trainings to develop your knowledge in this practice area?
